# GOVENOR RICK SNYDER VISITS LOCAL MAEAP VERIFIED FARM OWNED BY DAVE AND LYNN SKORNIA

Our very own Planning Commission Chairman, Dave Skornia and wife Lynn of Lakeside Farm in Bay Township were honored when Governor Rick Snyder accepted an invitation for a tour of their farm.

Lakeside Farm was recently recognized for being the very first in Northern Michigan and the 2nd in the State for attaining all four classifications of the Michigan Agriculture Environmental Assurance Program (MAEAP). Governor Snyder was able to observe firsthand the benefits of his very first act of legislation, the MAEAP Program, signed as Governor.

He was also quite interested in hearing about the farm's history, land preservation efforts, Boyne City, the areas local food movement, and the farm's innovative partnership with the Spirit of Walloon, a producer of fresh vegetables, which are also distributed to schools in the area.

## COMMUNITY SURVEY AND OTHER PLANNING COMMISSION ACTIVITIES

The Planning Commission is preparing a community survey to be distributed early in 2018. Your participation and feedback is essential! The results will provide a means for our residents to communicate their views on what they value and help give direction to the planning and governance of Bay Township. Please take time to share how you feel about our community, as well as any concerns you may have. The survey can be completed on line at <u>surveymonkey.com/r/baytownship</u> or may be completed in paper format and returned to the township by mail.

As zoning ordinances are intended to be relevant working documents that reflect the needs and wishes of the community, the planning commission has been working hard to provide fair guidance for land use while keeping up to date with current land use trends. We have recently completed language allowing accessory buildings on vacant parcels and currently working on an accessory dwelling provision to allow what are often referred to as "Granny flats". Both of these provisions are available on a case by case basis with the applicant completing the Special Use permit requirements.

# HOW CAN MY TAXABLE VALUE GO UP WHEN MY ASSESSED VALUE STAYS THE SAME OR EVEN GOES DOWN?

That is one of my most frequently asked questions. Assessments are a function of property value and property taxes are calculated on your taxable value. In 1994 Proposal A required property taxes be calculated based on the Taxable Value not the Assessed Value. By law, Taxable Values are annually increased or decreased each year by the CPI (Consumer Price Index) or 5% whichever is lower; unless there are physical changes to the property or a transfer of ownership occurred. The 2017 CPI is 1.009%.

During the 1990s and early 2000s, property values increased and greatly exceeded the annual CPI. This has created a gap between the Assessed and Taxable Values. Property taxes will continue to rise until the taxable value is equal to the Assessed Value. Therefore, it is possible for your assessment to go down, yet a Taxable Value will increase until the assessment and taxable value are equal. Proposal A does not permit the taxable value to ever be higher than the assessed value.

Our second annual township-wide trash pick-up was again well-received by the residents, and the Board of Trustees is already planning for next year. Jane and Bill Wehrenberg, as they did last year, coordinated and supervised the event. You might have seen them placing signs in late May and removing them after the event.


Kevin Russell, owner of Preferred Waste II, reported that his crews hauled away 173 cubic yards of trash. You might have a better picture of this by relating it to garbage trucks – our trash filled 7 garbage trucks. The process started on Thursday, June 8<sup>th</sup> and was completed on Saturday. Kevin indicated that the annual event went very well from his perspective. The company staff makes an effort to recycle metal by sending out a truck early to remove it from trash piles. Kevin asked if residents could make two piles, one of trash and one of metal, it would really facilitate his work. One other noteworthy fact is that the company kept their rates exactly the same as 2016.

Even though this was our second year, there were a few hic-ups. One is that the township has a few public roads that are fairly well-hidden, one being Wildwood Drive, close to Walloon Lake. This was missed by the haulers, but fortunately Jane and Bill were able to haul away the trash themselves. Two, some trash might have been placed along roads outside the township. Three, some residents forgot that their road was private; again, that trash was picked up by Jane and Bill. The Wehrenbergs stated that "It was nice that residents contacted them about problems so the issues could be dealt with immediately."

As we look to the future, there are a few points that bear repeating:

- All items must be placed along a non-seasonal public road in the township.
- Appliances, tires, construction/demolition waste, batteries, hazardous materials and yard waste will not be picked up.
- Other appropriate trash will be removed but residents should consider recycling items like electronics.
- Please do not worry if your trash is not picked-up the first day. The township is large and it takes several days to complete the work.
- There is no pick-up on private roads and seasonal roads.

For the last several years, I have had the privilege to serve on the Charlevoix County Planning Commission. A recent trip to Beaver Island brought home how important long term planning is to provide for the needs and the visions of communities.

The Mission Statement for the County Planning Commission reads, "It is the mission of the Charlevoix County Planning Commission to promote positive growth, recognizing multiple needs in terms of land development, conservation, recreation, transportation, and protecting the environment, resulting in better communities for future generations". An important aspect of the township fire service is the water sources. It would seem that with both Walloon Lake and Lake Charlevoix, water would not be an issue, but connecting a fire hose to a lake is actually not that simple. Problems include the force of the surface and the lake the lake the lake the service and the lake the lake the service and the lake th

force of the suction plugging the line with sand and debris and the lake being frozen. There are three locations in Bay Township that are used seasonally to directly draw water from to fight fires. (\*See Table) A special hose on the tanker fire truck is used to draw from these water sources. All other sources utilize dry hydrants. Dry hydrants are pipes permanently installed within a static water source, such as a pond, stream, river, or holding tank. Tanks are large, underground storage containers that are checked regularly to insure they are in working order and that the fire department has the correct equipment to connect to them. Our tanks have a capacity in the range of 10,000 gallons. This represents the ability to fill anywhere from four to six tanker trucks without the tank going dry.



The Boyne City Fire Department has just received their new 2300 gallon tanker truck which will further enhance our protection. The table above lists the locations and water sources utilized for fighting fires in Bay Township. The northern half of the township is serviced by the Resort/Bear Creek Fire Department and the southern half by the Boyne City Fire Department. One of the strengths of our fire depart-

ments is their strong support of "Mutual Aid". What this means is that when a department responds to a fire, other departments in the area immediately prepare to provide additional assistance if needed. Thus, there may be several tanker trucks from other departments shuttling water from our many water sources to the site of a fire in Bay Township. *Continued on page 4*

# HONORING OUR VETERANS

#### Join us on National Wreaths Across America Day at Dyer Cemetery on Saturday, December 16th

Each December on National Wreaths Across America Day, the mission to Remember, Honor and Teach is carried out by coordinating wreath-laying ceremonies at Arlington National Cemetery, as well as over 1,200 additional locations in all 50 U.S. states, at sea, and abroad, laying over 1,204,000 wreaths.

In 2014, the Bay Township Cemetery Committee teamed up with the Horton Bay United Methodist Church to form the BTAC group. We are very proud to be an official location for Wreaths Across America! Now in our 4th year, there are currently 47 known veterans buried in our 3 cemeteries in Bay Township. Our goal is to place a wreath on the grave of every veteran in our cemeteries: Oaklawn Cemetery on Horton Bay Road N., Dyer Cemetery on Camp Daggett Road, & North Bay Cemetery on Church Road. The national theme for 2017 is *I'm an American. Yes, I am.* In memory of Bay Township Veteran Gordon N. Lambie, our local group is dedicating this year's local ceremony to him. Annually, his support of our efforts to cover the gravesites in our township has been generously unwavering; even just prior to his death in August, he made certain wreaths were sponsored for this year.

Please plan to attend the Ceremony which begins at Dyer Cemetery on Saturday, December 16, 2017 at 11:45 (Sharp). You do not have to be a wreath sponsor to attend and be a part of this ceremony. At Noon (EST) a moment of silence will be held across the entire nation. Following a short ceremony, the wreaths will be placed on the graves of the veterans throughout the 3 cemeteries. The Boyne City American Legion Ernest Peterson Post 228, as well as local area veterans, will be assisting with this ceremony. It will be a very special time to be able to honor these men and women by placing a wreath that will mark their grave until the following spring.

## **BAY TOWNSHIP HOSTS MICHIGAN TOWNSHIP ASSOCIATION**

On October 30<sup>th</sup>, guest speaker, Park Gilmore, spoke to a packed hall on the benefits of using GRP (Ground Penetrating Radar) for cemetery investigations. Mr. Gilmore is President of Great Lakes Subsurface LLC of Spring Lake, Michigan, GPR is a geophysical method that uses electromagnetic waves in the radio frequency (400 MHz) to non-destructively locate objects in the ground. The results of the GPR survey can be marked in the field and/or presented in a site map indicating the location of each detected burial. Despite threatening skies, nearly all those in attendance followed Mr. Gilmore to Dyer Cemetery on Camp Daggett Road. Within 15 minutes of mapping, 7 unmarked burials were located in just one small area in the original (now closed) section of the cemetery. Regrettably, torrential rains brought the session to a close.

The benefit of locating unmarked grave sites is both financial and historical. Bay Township also has the one acre Oaklawn Cemetery on Horton Bay Road North which contains only 9 marked grave sites. The Bay Township Cemetery Committee is investigating the possibility of multiple uses of the cemetery once unmarked graves are identified and then reopening this cemetery.
