RESOLUTION 2022-04-03 ROAD MILLAGE BALLOT LANGUAGE

### BAY TOWNSHIP, CHARLEVOIX COUNTY BOARD OF TRUSTEES RESOLUTION RESOLUTION NO. 2022-04-03

**TITLE: Road Millage Ballot Language** 

WHEREAS, the Township of Bay, County of Charlevoix, State of Michigan, wishes to propose and levy a previously elector approved road millage to improve roads within Bay Township, and

**WHEREAS**, the Bay Township Board of Trustees, as authorized by Public Act 62 of 1933, MCL 211.203, allows for such millage to be levied for Bay Township road improvement purposes, and

WHEREAS, townships may impose and levy ad valorem property taxes to finance lawful public services, as authorized by the Michigan Constitution of 1963 and other laws; and

**WHEREAS**, the Bay Township Board of Trustees wishes to levy 1.0 mill to fund road improvements within Bay Township;

NOW, THEREFORE, BE IT RESOLVED, the Bay Township Board of Trustees, County of Charlevoix, State of Michigan, approves the following millage ballot question language and directs the Clerk to submit it to be placed on the August 2, 2022 Primary Election ballot:

This proposal establishes the renewal of a 1.0 mill road millage previously approved by the electors, which expired after the December 2021 levy, for the purpose of providing funds for township road improvements.

Shall the limitation on the amount of ad valorem taxes which may be levied by Bay Township, Charlevoix County, Michigan, against taxable property in the Township be renewed to the originally approved 1 mill (\$1.00 per \$1,000 of taxable value), and levied for three years, 2022 through 2024 inclusive, for the purpose of providing funds for construction and maintenance of roads within Bay Township, and shall the Township levy such millage for these purposes? If approved and levied in its entirety, this millage would raise an estimated \$173,000 for the Township in 2022.
