COTTAGE INDUSTRIES DISCUSSION

The PC members worked on the following homework prior to this PC meeting:

- Read section on Cottage Industries
- Drive around township and note how property owners are using parcels
 - ✓ Equipment/trucks in yard
 - ✓ Work being done on premise
 - ✓ Additional parking for visitors
 - ✓ Signage
 - ✓ Are people using home for home business

PC discussion included:

- ✓ Ordinance Language needs improvement/address purpose/categories description clarification
- ✓ What does the Township want to allow/not allow?
- ✓ Business debris outside/exposed
 - Visible accumulation
 - Employee parking
 - Growth is spreading
- ✓ Should Special Use Permits be required for Cottage Industries
- ✓ BOT or Police Power Ordinance
- ✓ Important to note that the PC does not want to discourage small home businesses just control accumulation of equipment
- ✓ Civil infraction?
- ✓ PC consensus to object to a Police Power Ordinance as it does not allow for anything to be 'grandfathered' in- gives ability to immediately resolve issues
- ✓ Would such an Ordinance cause the loss of the rural character of the Township that is so beloved?

Planning Commission consensus was NO large oversite NOR overregulation. PC also came to the consensus that the Cottage Industry is not causing the problem and the Cottage Industry
