ARTICLE 6 LANGUAGE

Anna (Tip of the Mitt) introduces herself and shared her background. After working in research labs, in the field of environmental science she has settled into environmental policy. She will be picking up from where Kacey Cook left off working with the PC on Article 6 and permit application. Discussion with PC members included:

- Needs to be clear in zoning ordinance regarding penalties for violations
- Ideas to make violation enforcement hold up in court (specific/vague/nuisance)
- Make clear what is allowed and what is prohibited in Shoreland Protection Strip
- Match zoning ordinance with zoning application
- Bonds- may be difficult for a private person to get a bond
- Bond may be set by- complexity of project/value of project/total lake frontage/etc.
- Proposed Shoreland Protection Strip may be reviewed and approved as a Special Use Permit by PC after review and presentation by a Shoreland Protection Strip Committee
- Restoration Requirements language regarding erosion, specifically rip-rap, possible add language to shift people away from using rip-rap (EGLE does have language in their policy regarding acceptable rip-rap uses) and encourage alternate options (bio-engineering/etc.)
- Grant monies/cost share thru EGLE available to homeowners for restoration of shoreland strip
- Rewards and incentives vs prohibition of rip-rap
- Language includes vegetative buffer/greenbelt/shoreland protection strip which to use. Shoreland Protection Strip
- Adding second definition of pervious as well as impervious
- Ordinary High-Water Mark (OHWM) defined as physical mark on shore as well as defining the elevation per State of Michigan
- Current language in ordinance includes 'or from the property line' which complicates and if changed could create additional non-conformities
- Should language be added for approval from State prior to issuing a permit at Township level
- Permit application is Phase 2 after Article 6 is adopted
